

Champion of Justice

The Attorney General's Office



Nevada Attorney General Aaron D. Ford was sworn in as Nevada's 34th attorney general in 2019, was re-elected in 2022, and is the first African American to take statewide constitutional office. Before his election, AG Ford served as the Majority Leader of the Nevada State Senate. He previously served as the Minority Leader, Assistant Majority Whip, chair of the Senate Committee on Natural Resources, vice chair of the Senate Committee on Education, and member of the Judiciary Committee. Before beginning his legal career, AG Ford served as a public school math teacher. He later attended law school and went on to clerk for the Honorable Denise

Page Hood of the U.S. District Court for the Eastern District of Michigan, as well as the Honorable Johnnie B. Rawlinson of the U.S. Court of Appeals for the Ninth Circuit. He spent many years in private practice, including as a Partner at Snell & Wilmer LLP and later as Partner at Eglet Prince, both in Las Vegas. AG Ford earned his B.A. from Texas A&M University in Interdisciplinary Studies and then earned his M.A. in International Education from George Washington University. He also earned an M.A. in Educational Administration, as well as his law degree and Ph.D. in Educational Administration from The Ohio State University.

Pro Bono Legacy Award

Rodney E. Sumpter, Esq.



Rodney Sumpter began his legal career in the State of Nevada in September 1980 after his graduation from the University of the Pacific, McGeorge school of law and passing of the bar. Rodney always espoused volunteerism as a way of life. From his early days doing pro bono work through the Washoe County Bar Association, then Washoe Legal services and Nevada legal services. In the late 1980s and early 1990s Rodney was a charter member of the Washoe County domestic violence task force, which set up protocols for dealing with domestic violence matters and in particularly matters that arose after court hours and on the weekends for which he served as a Protem judge and advocate. The steady pace of his pro bono work resulted in numerous accolades from the Washoe County Bar Association, Nevada Supreme Court, and ultimately his volunteering for Nevada legal services, where he

has regularly dedicated his time for the last 20 plus years in addition to his thriving law practice. Rodney's philosophy of steady and continuous service to the financially challenged and those in need of legal assistance in Washoe County and in other parts of Nevada has resulted in his performing thousands of hours and hundreds of matters of pro bono services during his career. Rodney retired from the practice of law in July 2025 after 45 years of active practice. Although he retains his license, he intends to use it for continuing his pro bono service into the foreseeable future.

Rodney lives in Reno with his spouse of 15 years, Jorge Farinacci. The couple loves traveling the world, being on their boat at Lake Tahoe, going to their second home in Puerto Rico, volunteering at their spiritual center and volunteering in the community for various causes.

Pro Bono Attorney of the Year

Homa Sayyar, Esq.



Homa Sayyar is an attorney licensed in Nevada and Oregon who graduated from the University of Nevada Las Vegas William S. Boyd School of Law with her JD in 2007. She has been a state employee in various roles since relocating to Northern Nevada from Las Vegas in 2017. Currently she serves as one of two Deputy Directors at the Nevada Department of Indigent Defense Services (DIDS).

Homa's most notable career development from private practice (or at least the one that is the most fun to share) is having been included in Last Week Tonight With John Oliver's episode about guardianship regarding a matter where she was pro bono counsel for a protected person seeking damages against their former exploitative guardian.

Her proudest moments as a public lawyer have come from seeing legislation in action that she assisted with for the benefit of Nevadans with disabilities. These bills included AB 480 (Supported Decision-Making Agreements) and SB 121 (Powers of Attorney for Dementia) in 2019, SB 61 in 2023 (addressing an issue with the laws regarding joint tenancy of bank accounts in exploitation cases), and AB 336 in 2025 (correcting procurement laws that could negatively impact Nevada veterans with service-connected disabilities).

Nevada Legal Services makes volunteering for "Ask a Lawyer" sessions easy and all the more possible for public or government lawyers to do a small part. Homa is happy to have attorneys shadow her for virtual or in-person sessions if they are nervous about what it involves. She believes that even if you have no experience in a particular area of law, listening to someone and helping them consider how best to communicate their story makes a difference.

Homa is privileged to be the mother of two kind, resilient children. They live with their three dogs and three cats in Carson City.

The mission of the Nevada Department of Indigent Defense Services (DIDS) is to assist Nevada counties in developing quality, equitable, and sustainable indigent defense systems that strengthen local communities and meet or exceed the state and federal constitutional guarantees that protect each of us.

The goals of DIDS are to build a strong and resilient statewide network of effective indigent defense providers and to support them with regular education, training, and other defense-specific resources, including experts, investigators, social workers, and other valuable tools. DIDS also seeks to create a centralized resource center that provides holistic defense services and complex litigation assistance. DIDS is working to create a pipeline program through Boyd School of Law at UNLV, to bring more qualified indigent defense attorneys into the rural areas.

Pro Bono Attorney of the Year

Robert J. Angress, Esq.



I grew up in a large family created by my immigrant parents; my father escaped from Nazi Germany to America, where he finished his medical education and worked as a psychiatrist in the juvenile courts, eventually opening a private practice in Chicago. He was lecturing at the University of Chicago when he met my mother, an Egyptian Muslim, who subsequently garnered four degrees from U of C. I sought to follow in my father's footsteps since the age of 12, only pivoting from medical school in 1972 to law school in 1973. Having graduated from the University of Michigan in 1972, I became the first graduate of Vermont Law School in 1976. Moving with my wife to Nevada in 1977, we settled in Incline Village. I worked as a Deputy Legislative Counsel, State of Nevada from October of 1977, then left to start my private practice in June of 1979, and have appeared before the state and federal courts of Illinois, California and Nevada since then. I was admitted to practice before the Supreme Court of the United States in 2009.

The primary focus of my practice is to learn about the lives and goals of my clients in order to integrate and apply the lessons I have learned from nearly 50 years as an attorney, decades as a pro tem judge, my years of teaching legal classes in University and Law School, as well as involvement in the community in myriad areas of parenthood, charities, vocal performance music, and service to veterans. From these experiences, it is my perspective that the American legal system, while a shining example of theoretical equity, is actually an unwieldy recourse for redressing wrongs that is routinely impractical from an economic and temporal aspect. Thus, my practice keeps these obstacles in mind when counseling clients about how to design their business organizations, construct their contracts, conduct their business or profession, plan their estates, and respond to civil wrongs which they encounter in making their livelihood and managing their families.

My practice has been characterized by using the details I learn with regard to those aspects of my clients' lives in order to optimize my contribution to the management and solution of their legal problems. I was blessed by chance to land in Incline Village, Nevada (a refuge for emerging tech entrepreneurs from California primarily) and had the opportunity to assist some of the most successful business people in the world in the last two decades of the 20th century and the current two and a half decades of this century. When asked what has distinguished my practice as an attorney, I usually wryly respond: "I don't drink and I return phone calls." Few have inquired further. Once my father, prone to lamenting that I did not finish medical school, commented that I had ended up being a therapist anyway, using the law instead of medicine to deal with problems.

Rural Attorney of the Year

Norman Allen, Esq.



Norman Allen was born in Schurz, Nevada in May 1947 and graduated from the public schools in Fallon, Nevada. He grew up in Churchill County and is an enrolled member of the Fallon Paiute-Shoshone Tribes.

Allen enlisted with the United States Marine Corps and served from 1967 through 1969 as an infantry assaultman with a one year tour in Vietnam. After his enlistment, Allen enrolled at the University of Nevada, Reno and graduated in 1982 with a degree in Business Administration/Public Administration. Allen then was appointed as Executive Director of the Nevada Indian Commission from 1967 through 1969.

After his appointment concluded, Allen enrolled at and graduated from the University of San Diego School of Law in California. Following graduation, Allen was appointed as a deputy attorney general at the Nevada Office of Attorney General. During his term of service, he handled matters including personal injury, wrongful death, eminent domain, employment

discrimination, personnel, construction contracts and open range matters. Allen served for eight years with the State Bar of Nevada Northern Disciplinary Committee. Allen retired in 2013.

Growing weary with retirement, Allen volunteered with the Nevada Legal Services and Office of Military Legal Service to assist low-income clients and to assist veterans on various legal matters involving family law and estate planning. Allen presently conducts a solo practice primarily with the various tribal courts in northwest Nevada.

With veteran matters, Allen held various positions with the veterans' community. These communities included the Vietnam Veterans of America (VVA), Third Marine Division Association, Marine Corps League (MCL), United Veterans Legislative Council and the Veterans of Foreign Wars (VFW). Among his various positions, he has participated with the VVA Color Guard, was elected for two terms as MCL Department Judge Advocate, selected as National Aide-de-Camp for VFW and was elected for four consecutive terms as a VFW District Commander. Two of these four terms included the achieving of All-State and All-American honors for his VFW District. In October 2020, Allen was selected as the NDVS Veteran of the Month in the State of Nevada.

Allen is an active member of the Nevada State Bar, a certified Nevada Veterans Advocate with the Nevada Department of Veterans Affairs (NDVS), and an accredited claims attorney with the Office of General Counsel, U.S. Department of Veterans Affairs.

Nancy Moss Ghusn, Esq.



Nancy Moss Ghusn has been an attorney in Northern Nevada for over 30 years. A product of local schools and a proud alumna of the University of Nevada and Seattle University School of Law, she has donated her time to benefit the Northern Nevada community in various ways. Early in her career, she helped to establish and served as an original director of Volunteer Attorneys of Rural Nevada (VARN), served on the City of Reno Parks and Recreation Commission, including as its chair, represented clients from the predecessor to Washoe Legal Services, receiving its “Outstanding Lawyer” Pro Bono award, is a proud member and was president of Northern Nevada Women Lawyers (and that group’s nominee for Nevada Women’s Fund “Women of Achievement” award), and has participated in innumerable legal clinics, including NLS, “Project Salute,” and VARN. She currently serves on the Board of Directors of Nevada Legal Services, Sierra Nevada Ballet, and the Whittemore Peterson Institute in Reno.

In her professional capacity, Nancy has served as and is currently a pro tem Justice of the Peace for Reno Justice Court for over 20 years, is an administrative hearing officer at the city, county, and state levels, and was a Family Court Master for approximately ten years. She enjoys spending time with her husband, son and daughter, beloved pets, and almost anything outside when it’s not smoky. She loves Lake Tahoe, travels whenever possible, and when it’s not possible, she has at least four live webcam streams of beautiful and interesting places in the world on her laptop. She’s a particular fan of the Fat Bears catching salmon in Alaska.




